Gentle Customer,

The undersigned Incas S.p.a., as Data Controller, hereby informs you that, pursuant to article 13 of EU Regulation 2016/679 concerning the protection of personal data (hereinafter the Regulation), for the establishment and execution of Contractual agreements is or may be in possession of information related to you.

1. Type of personal data processed

The following personal data may be processed: personal data, tax information, contact details, bank details and other administrative or commercial data necessary for the purposes indicated below.

2. Purpose of the processing

The data will be processed for the following purposes:

a) compliance with legal obligations and execution of the contract of which you are a party, fulfillment of obligations towards the Financial Administration, accounting and administrative management, management of existing commercial relations and management of legal disputes;

b) sending of e-mail regarding technical and promotional material also in collaboration with companies or professionals of our trust, and relating to products and services, as well as for carrying out surveys in order to evaluate the degree of user satisfaction (so-called customer satisfaction)

3. Legal basis

The legal basis for the processing of personal data indicated at point 2.a) is the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract. The provision of personal data is necessary to fulfil the legal and contractual obligations, therefore any refusal to supply them, will make it impossible for the Data Controller to provide the requested service.

The legal basis for the processing of personal data indicated at point 2.b) is the legitimate interest of the Data Controller to use the email coordinates you provided, in order to keep you updated on new initiatives.

We remind you that you have the opportunity to object to this processing at any time and in an easy way and for free, simply by writing to the email address: incas@incas.it

3. Recipients of personal data

Designated personnel, appropriately trained and operating under the authority and responsibility of the Data Controller, will process the data. Some of the information can be communicated to the subjects indicated below: Public bodies (Tax Offices and other entities); Law or consulting firms to which the Data Controller has assigned a specific mandate; Support and maintenance companies of IT systems or digital archiving systems; Other subjects or companies that carry out activities instrumental to the purposes listed above. The detailed list of these subjects is available at the headquarters of the Data Controller and will be provided at your request by writing to the following e-mail address: incas@incas.it

4. Rights of the data subject

We also inform you that, with respect to the data, you can exercise the rights provided by the CHAPTER III of the Regulation at any time.

In particular, you have the right to request access to the data concerning you, their correction, deletion, or integration of incomplete data, the limitation of processing; to receive data in a structured, commonly used and machine-readable format; to object in whole or in part to the usage of the data, as well as to exercise the other rights recognized to you by the applicable discipline.

According to the art. 77 of the Regulation, moreover, you have the right to lodge a complaint with the Supervisory Authority if you consider the processing infringes the aforementioned Regulation.
